Context

- The Building Bridges Initiative (BBI) and its Outcomes Workgroup identified the need for a tool **to support measuring the impact** of residential interventions **that can also support programs in improving quality** within a system of care framework.
- It decided to use a theory of change and logic model design to help to achieve this objective and capitalize on the opportunity.
- BBI engaged ACRC conference participants to help validate and refine the theory of change at both the 2021 and 2022 conferences.

Overview of Theory of Change

- ✓ A method used to select an intervention
- ✓ A model of the expected causal relationships that lead to desired outcomes
- ✓ Helps us articulate our assumptions about how change will occur
- ✓ A visual representation of a change process
- ✓ Can be used at different stages depending on the purpose

WHY A THEORY OF CHANGE?

- **Achieve buy-in:** A theory of change helps partners and stakeholders get on the same page about what needs to happen to reach shared goals.
- **Select the right intervention(s):** A theory of change articulates desired short- and long-term outcomes and sets the groundwork for finding the best approach for achieving them.
- **Guide strategic planning:** A theory of change can serve as a practical tool for focusing attention and decision-making throughout the change process.
- **Inform evaluation and continuous improvement:** A theory of change helps program staff and evaluators identify what indicators to measure to monitor progress, assess needed adjustments during implementation, and evaluate overall results.

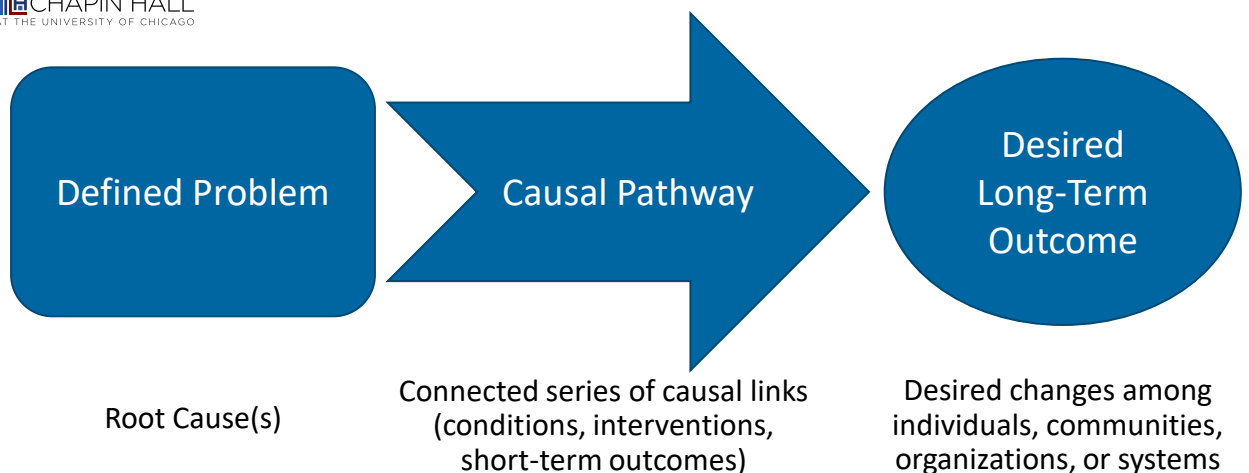

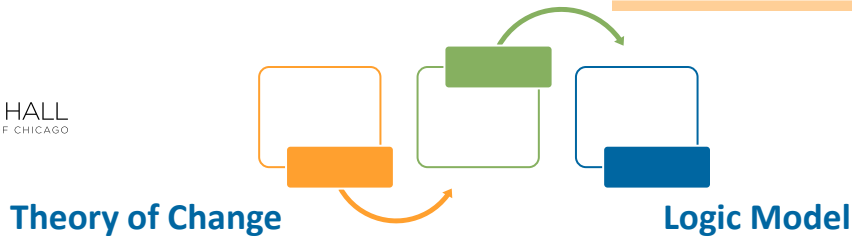

Theories of Change



Capacity Building Center for States (2018) Advancing partnerships among residential and community-based service providers, youth and families to improve lives.

- Illustrates the pathway from the root cause(s) of the problem to the desired outcome
- Helps explain how and why change will occur
- Supports intervention selection
- Presents program inputs, activities, outputs and outcomes in a structured grid format
- Helps stakeholders understand expected results
- Supports monitoring and evaluation

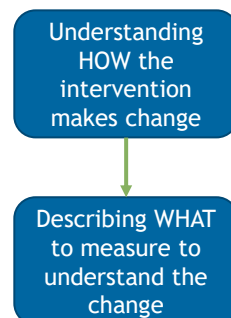

How the Theory of Change and Logic Model Work Together

- A **theory of change** describes the expected causal relationship between the (residential) intervention and its impacts for youth and families.
- **Logic models** clarify the mechanisms by which the (residential intervention) achieves the intended effects, thereby operationalizing the theory of change as an actionable evaluative framework.



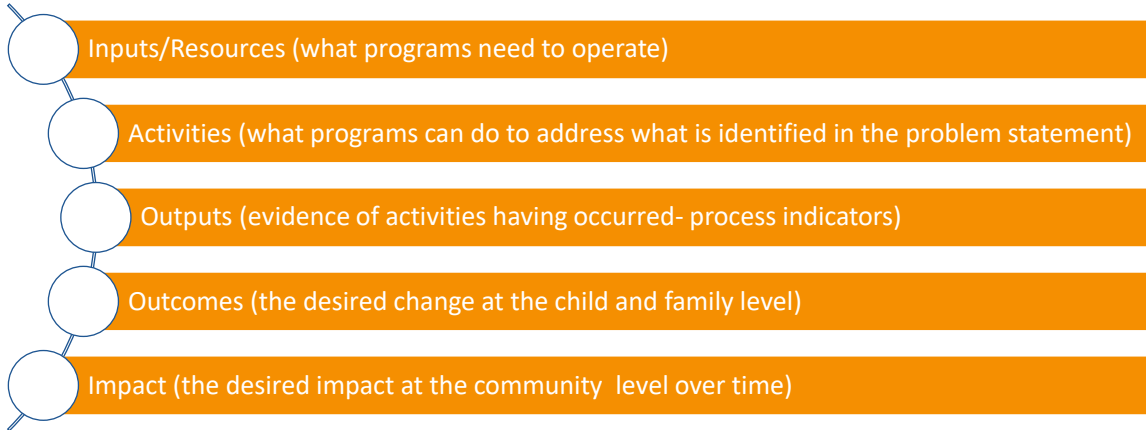

LOGIC MODEL COMPONENTS



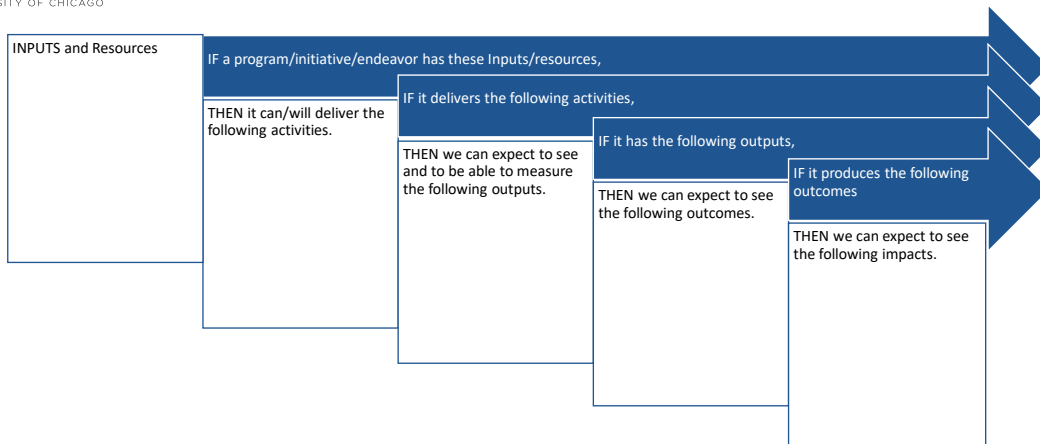

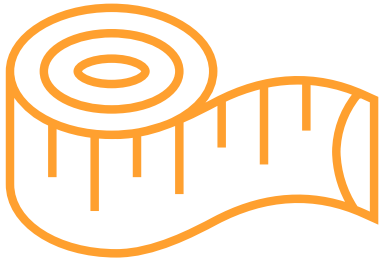

Measuring Change



- **Process measures:** A measure of whether an activity has occurred
- **Functional outcomes measures:** A measure of the effect of an intervention
- **Experience measures:** A measure of the value of the experience from the family's perspective

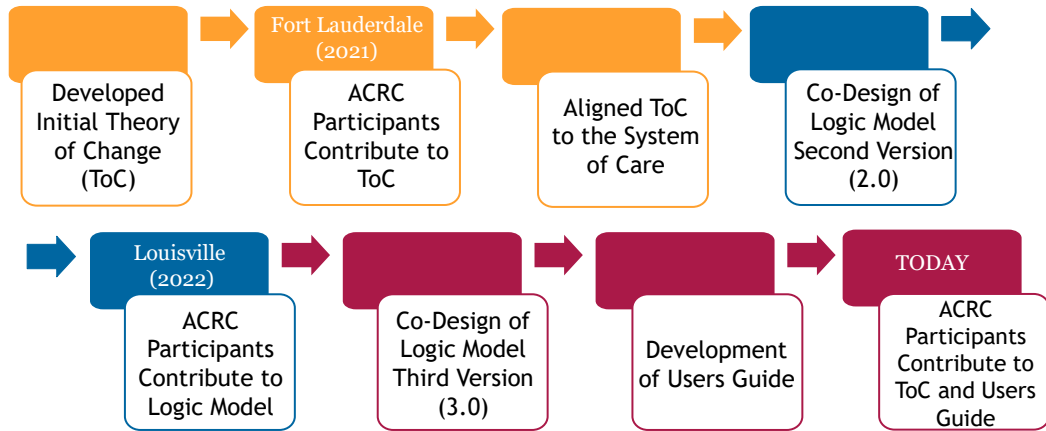

BBI SYSTEM OF CARE PILLARS



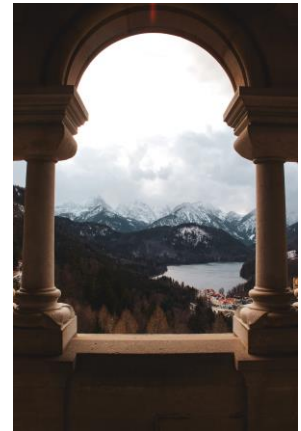
