Mental Health of LGBTQ+ Young People

The Trevor Project released the [**2024 U.S. National Survey on the Mental Health of LGBTQ+ Young People**](#), which highlights the experiences of more than 18,000 LGBTQ+ young people ages 13 to 24. The findings underscore that LGBTQ+ young people continue to report high rates of mental health challenges, suicide risk, and associated experiences of anti-LGBTQ+ victimization.

Strengthening Protections for LGBTQ+ Youth in Foster Care (Part 2)

*In April 2024, the U.S. Department of Health and Human Services released a historic final rule that directs State and Tribal agencies to fully implement existing protections for LGBTQ+ youth in foster care. In recognition of Pride Month, this Policy Corner focuses on ways that states can go beyond the [**latest HHS rule**](#) to further protect youth involved in the child welfare system with diverse sexual orientation and gender identity (SOGIE).

Below are examples of state policy mechanisms curated by [**Innovations' SOGIE Center**](#) that focus on protecting and supporting this population in child welfare systems:

- State agency policy and regulations can explicitly prohibit discrimination on the basis of sexual orientation or gender identity for youth in the child welfare system.
- States can mandate in statute that transgender youth be treated in accordance with their gender identity, including placements.
- States and agencies can implement data collection on SOGIE status in child welfare agencies by setting up data fields within existing data collection mechanisms so that SOGIE data can be entered, and by training child welfare workers to ask youth about their SOGIE.
